Appendix A - Forensic Fee Schedule for Dr. Emily B. Fine, Ph.D., QME as of January 1st, 2025

Evaluation Fees

- Records/file review - \$500/hour
- Clinical interview - \$500/hour
- Psychological testing, including scoring and interpretation - \$500/hour
- Neuropsychological testing, including scoring and interpretation - \$500/hour
- Report writing - \$500/hour
- Consultation with attorneys and other professionals - \$500/hour
- Deposition and testimony preparation - \$500/hour

Deposition and Testimony Fees

- Deposition time, has a 2-hour minimum - \$1300/first 2 hours, \$650/hour each additional hour (paid 72 hours in advance)
- Testimony time, including courtroom waiting time, has a half-day minimum - \$2600/half day, \$650/hour each additional hour (paid 72 hours in advance)

Travel Fees

- Travel time with reasonable associated expenses - \$150/hour

Payment Policy

For Forensic Evaluations, a retainer of \$8000 is customarily submitted along with the retainer agreement for Dr. Fine's services to reserve the appointment. For Deposition and Testimony, a retainer of \$1300 and \$2600, respectively, is customarily submitted along with the retainer agreement for Dr. Fine's services. All retainer payments must be submitted, along with the retainer agreement, in order to begin work on a case. Upon utilization of all fees submitted, weekly invoices will be sent to counsel, and are due upon receipt. Failure to complete payment each week will result in the cessation of work and/or cancellation of any scheduled appointments, pending account payment. Unused retainer balances are returned as credit.

Cancellation Policy

Please contact Dr. Fine at 909-480-8235 to cancel any appointment. Cancellation of a forensic interview and/or testing appointment must be made 72 hours prior to that appointment. Since a full day is set aside for the evaluation and alternative bookings are unlikely at such short notice, if an evaluation appointment is cancelled less than 72 hours prior to the evaluation for any reason, including settlement, or if the litigant fails to attend or complete the evaluation, there is a

\$2000 cancellation fee. For deposition and courtroom testimony, a charge of \$1300 and \$2600, respectively, will be assessed if such service is cancelled or continued with less than 72-hours' notice. Similarly, when Dr. Fine is asked to be on-call and is provided with less than 72-hours' notice that she will not be needed for courtroom testimony, a charge of \$2600 will be assessed.
